ORDER UNDER SECTION – 30 OF THE DISASTER MANAGEMENT ACT - 2005

Whereas, the India Meteorological Department (IMD), Shimla has issued a **Red Alert for 02nd September, 2025 for District Sirmaur, warning of Very heavy rain at few places with extremely heavy rain likely at isolated places**, which may potentially lead to incidents of landslides, flash floods, uprooting of trees, road blockages, and pose grave danger to life and public safety.

And whereas, the district has been experiencing continuous rainfall leading to obstruction of rural roads, increased risk of landslides and general disruption of normal life, particularly in rural and hilly areas. Such inclement weather conditions are likely to endanger the life and safety of students commuting to and from schools across the district

And whereas, it is deemed expedient and necessary to take **precautionary measures in public interest** to avoid any untoward incident and to safeguard precious human lives, especially that of school children.

Now, in view of the above, and in exercise of the powers conferred upon me under Section 30, Sub section (v) of the Disaster Management Act, 2005, I, Priyanka Verma, I.A.S, **District Magistrate-cum-Chairperson, District Disaster Management Authority, Sirmaur**, hereby order the **closure of all Government/Private Educational Institutions and Anganwaris on 02nd September, 2025 in District Sirmaur** as a precautionary measure. Further, teachers and other employees of these institutions are also exempted from attending institutions on 2nd September 2025. However, all efforts should be made to conduct online classes to keep students engaged

All concerned **Government and Private Educational Institutions** and administrative officers are directed to ensure strict compliance of this order.
